**MOTION TO WITHDRAW OF
SOUTHWEST POWER POOL, INC.**

Pursuant to sections 35.17 and 385.212 of the Federal Energy Regulatory Commission's ("Commission") Rules and Regulations, 18 C.F.R. §§ 35.17 and 385.212, Southwest Power Pool, Inc. ("SPP") moves to withdraw the compliance filing submitted by SPP in Docket No. ER12-457-000 on November 21, 2011.¹

On November 21, 2011, SPP submitted the Compliance Filing in response to the Commission's October 20, 2011 order² in Docket No. ER11-3627-000. Due to an administrative error, the Compliance Filing was submitted in the SPP eTariff system in a new docket, Docket No. ER12-457-000, rather than in existing Docket No. ER11-3627.

This afternoon, SPP re-submitted the Compliance Filing through eTariff in Docket No. ER11-3627-001, and submits this motion to withdraw the Compliance Filing as submitted in Docket No. ER12-457-000. SPP served a copy of the Compliance Filing on all parties on the service lists established by the Commission Secretary's Office in Docket Nos. ER11-3627-000 and ER12-457-000, and will serve a copy of this motion on the same parties.
