For the submittal of potential transmission solutions not submitted as DPPs (non-DPPs, such as operating guides, or Order 890 submittals), **all** additional non-DPP stakeholder submittals need to be received by **11:59 p.m. CDT on Friday, October 30, 2015**, in order to meet study timelines. Any non-DPP or Order 890 solution submittals received after that date are not guaranteed to be evaluated in the 2016 ITPNT. The [updated DPP Submittal Form](#) is the preferred method for receiving all solution submittals, including non-DPP and Order 890 solutions.

The MISO potential overload and voltage issues have been added to the posted 2016 ITPNT needs assessment on TrueShare, and are being provided for **informational purposes only** to provide additional transparency in identifying potential interregional solutions.
