



# Notification of Posting and Approval Date Changes for the 2020 MDWG and 2021 ITP Models and 2021 ITP Load and Generation Review

## • Informational Posting - No Action Required

Due to the delays in the 2020 ITP needs assessment communicated to stakeholders on February 20, 2020, staff realized there are additional impacts due to overlapping stakeholder reviews being requested during the same timeframe for the 2020 MDWG powerflow and short-circuit model build, as well as the 2021 ITP load and generation review, and the 2021 ITP powerflow and short model builds. The revised 2020 ITP and 2021 ITP schedule dates will be included in a presentation given at the upcoming February 26, 2020 Joint ESWG/TWG teleconference.
