- **Action Required**

- SPP staff requests stakeholders review the 2024 ITP draft project list and provide feedback. The draft list of projects for the 2024 ITP has been posted to [GlobalScape](#). The intent of this project list is to be a living document showing the top-ranking projects staff has identified to solve the remaining needs which have not been addressed by model adjustments, previously issued NTCs, or operating guides. SPP staff will continue posting updates to the project list throughout the study. This project list posting will be used to inform members of which projects are still under consideration.
- Stakeholders should review the cost estimates and notify SPP if there are any impactful monetary differences. In addition, stakeholders should review projects for feasibility and notify SPP if the posted project is not feasible to construct.

- **Entities Required to Provide Feedback:**

All interested stakeholders.

- **Due Date and Method of Submittal**

Feedback related to the draft project list is requested as soon as possible but no later than end of day **Monday, July 8, 2024**.

Feedback regarding the updated draft project list should be submitted via the SPP Request Management System (RMS), using the “Submit an Inquiry” Request Template, with Subtype 1 as “Integrated Transmission Planning (ITP)” Subtype1, and Subtype 2 as “Data Submission”.

- **Changes from Last Pass:** Incorporated stakeholder feedback, added additional projects sent out in Batch 3. Added grouping details for projects that have been selected for grouping. Added Model Corrections collected so far for the 2024 ITP.
